From the Desk of President Deb Peterson

The following describes the Political Endorsement Policies of NYSUT and UFT. A special nod of appreciations goes out to Ken Goodfriend and Tom Murphy.

One of the obligations of NYSUT, NYSUT RC 43, the UFT and the Retired Teachers Chapter is to keep you informed of the issues that are extremely important to our members and about those elected officials who have an impact on our fundamental issues: e.g. Health Care, Social Security, Support for Public Education, and Respect for Human Rights, and Support for Working Families.

To this end, we listen carefully to our partners in labor and education who interview those candidates running for office and review those candidates' records regarding the above issues. Our Florida brothers and sisters deal every day with their elected officials and the recommendations for endorsement they make are because they feel the candidate(s) will best support those issues that we all hold dear.

The endorsement of a candidate for President is made by the American Federation of Teachers, the National Education Association, the national AFL-CIO, and the national Alliance for Retired Americans. The Florida AFL-CIO, the Florida Education Association, and the Florida Alliance for Retired Americans make the endorsements for the State Legislative and Congressional races. On the local level, the various AFL-CIO Central Labor Councils and local teacher unions around the State make endorsements for their City/Town Councils, County Commissioners and School Boards.

The following criteria for endorsements in local elections: Does the candidate support our efforts to achieve, maintain and advance the economic and professional interests of our members and strengthen labor and human rights? We view that mandate as support for public education and the children we serve as the mission of our professional vocations.

Endorsement criteria allows for supporting candidates from either party when their views and policies support our members' interests. The pension and health coverage we enjoy as retirees today is a result of our relationship with public officials of both political parties.

Unfortunately, on the national level today, the policies of one political party are in sharp opposition to core issues vital to our members' economic security and professional interests. One party's crusade against public employee pensions, attempts to destroy collective bargaining, support for the Friedrichs case threatening fair share/agency fee and efforts to privatize Social Security, voucher Medicare, block grant Medicaid and support voter suppression laws threatens the bedrock of the labor movement and would undo a century of progressive labor accomplishments. Support of private school vouchers and the use of charter schools as weapons against the traditional public schools, undermines our entire professional belief system.

Ultimately, each member enters the voting booth alone to make that very personal voting decision. Sometimes the strongly held personal views of members on particular issues override union recommendations. That is a democratic right. Remember, every vote matters.

NYSUT President Karen E. Magee said candidates' voting records and their working relationships with **NYSUT** members in their home districts were among the important factors in whether a candidate earned the union's support. "Candidates earning **NYSUT**'s endorsement this year have shown a willingness to listen to our members in public schools, colleges and hospitals. They value their relationships with our more than 600,000 politically active and energized members and champion their interests," Magee said.

NYSUT Executive Vice President Andrew Pallotta said the **NYSUT** endorsement process "is truly a grassroots, organic process, with **PAC** members and local presidents surveying their own members in their own communities about who they wished to see **NYSUT** support in this year's elections," Pallotta said. "Those candidates who earned **NYSUT**'s endorsement have won the backing of members in their home communities."

THE ALLIANCE FOR RETIRED AMERICANS 2015 VOTING RECORD REPORT

The Alliance for Retired Americans released its 2015 voting record report which scored every U.S. Representative and Senator on key issues affecting current and future retirees. The voting record examined 10 key Senate votes and 10 key House votes in 2015, showing the roll calls on issues such as:

- attacking our core retiree programs of Social Security, Medicare, and Medicaid;
- 2. passing fast track trade authority, which extinguishes the ability to scrutinize and amend proposed trade agreements that would lock in higher drug prices; and
- 3. addressing income inequality by raising the minimum wage

"Unfortunately, the new Congress that came to town did not help improve the nation's retirement security," said Robert Roach, Jr., President of the Alliance. "We had an opportunity for change but we didn't take advantage of it. Nine of 12 freshman Republican Senators scored zero, and the others scored 10%. This Voting Record reflects how committed our elected representatives are to seniors.
