

The year 2016 marks the AFT 100th Anniversary Celebration (1916-2016) of "Honoring Our Past & Inspiring Our Future." Union Brothers & Sisters from all over the country will meet in Minneapolis on July 18 – 21, 2016 to further advocate for the ideals and principles set forth in the AFT Mission Statement.

The American Federation of Teachers is a Union of Professionals that champions fairness; democracy; economic opportunity; high-quality public Education; and Healthcare and Public Services for our students, their families and our communities. As members, we are committed to advancing these principles through community engagement, organizing, collective bargaining and members' political activism.

The American Federation of Teachers, an affiliate of the AFL-CIO, today represents 1.6 million members in more than 3,000 local affiliates nationwide, including NYSUT. NYSUT RETIREES PROPOSED THE FOLLOWING RESOLUTIONS FOR THE DELEGATES OF THE 44TH ANNUAL REPRESENTATIVE ASSEMBLY ON APRIL 8-9, 2016:

RESOLUTION #18 - RETIREE VOTE-COPE

RESOLVED, that NYSUT consider changing the current practice and recognize their Retirees and Retiree Council efforts in the VOTE/COPE program by returning a portion of the dollar amount contributed by retirees designated as 999 to the Retiree Councils.

RESOLUTION #20 - OPPOSE THE 2017 CONSTITUTIONAL CONVENTION

RESOLVED, that NYSUT redouble its efforts against a Constitutional Convention in New York State; and be it further

RESOLVED, that NYSUT wage a public relations campaign to convince the public of the futility of holding a Constitutional Convention in 2017.

RESOLUTION #35 - PRESERVE AND REINSTATE SOCIAL SECURITY

RESOLVED, that NYSUT urge more active support for maintaining and improving Social Security by its national affiliates, and be it further

RESOLVED, that NYSUT urge its national affiliates to support returning to the previous practice of no taxation of Social Security income.

MISSION STATEMENT

The mission of Retiree Services is to facilitate the process by which NYSUT and its affiliated retiree groups promote union goals and enrich the lives of retirees as these groups provide organizational, educational and social programs and activities by:

- > Assisting in improving communication between NYSUT and retirees;
- > Encouraging retirees to participate more fully in NYSUT retiree organizations;
- Assisting and encouraging retirees to participate in union-endorsed advocacy campaigns;

NYSUT RETIREE GOALS:

HOW SUFFRAGIST POSTCARDS GOT OUT THE VOTE

Considering what obvious justice suffrage for women was, it's surprising that it took 62 years from the birth of the U.S. suffrage movement to come up with an equally simple way of making the case. But in 1910, the NATIONAL **AMERICAN WOMAN SUFFRAGE** ASSOCIATION distilled their best arguments into oneparagraph gems printed on postcards. Their "Think It Over" series proved to be not only an excellent consciousness-raiser but fundraiser as well, since NAWSA received a commission on each card sold. Though people today generally associate black and white images and grim determination with the suffragists, here's proof from 1916 that they could be colorful and whimsical:



THE CONSTITUTION AND BY-LAWS OF RETIREE COUNCIL 43 AND TEACHER RETIREES IN FLORIDA (TRIF) UNITS HAVE BEEN AMENDED!

The membership of the NYSUT RC 43 TRIF Units voted during their February meetings to approve the proposed amendment to the Constitution and Bylaws as follows:

EXECUTIVE BOARD

F. The Term of Office for the NYSUT Retiree Council 43 Executive Board shall be for three (3) years and shall begin at the conclusion of the NYSUT Retiree Council 43 Annual Conference.

TRIF UNIT ELECTIONS

E. Term of Office. Duly elected officers shall serve a three (3) year term commencing at the conclusion of the last business meeting of the year. Each officer shall remain in office until his/her successor assumes the office.

(Each of the terms was extended from two to three years to be in compliance with NYSUT, which has gone to a three (3) year Election Term.)

The above amendment had been approved by the Executive Board on Sept. 28, 2015, and by the Delegates at the General Assembly on Sept. 29, 2015.

The present RC 43 Board and TRIF Unit Officers will extend their present term to the next Election Cycle in the Spring of 2017.
