# FROM THE DESK OF PRESIDENT DEB PETERSON ELECTION NOTIFICATION FOR TRIF UNITS & RC 43 OFFICERS

ALL TRIF UNITS MUST HOLD ELECTIONS FOR THE 2017 - 2020 TERMS OF OFFICE

In accordance with the NYSUT Retiree Council 43 and TRIF Unit Constitution and Bylaws, the following guidelines MUST be followed for the election of TRIF Unit Officers. Nominations for TRIF UNIT Officers, Delegates and Alternate Delegates to NYSUT Retiree Council 43 shall be made in the following manner:

The Officers of TRIF UNITS shall be President, First Vice President, Second Vice President, Secretary and Treasurer. The immediate Past President shall be a member ex-officio of the TRIF UNIT Board of Directors.

A nominating committee composed of no less than three (3) nor more than five (5) active fee paying members shall be appointed by the President in January of each year in which elections are scheduled.

The Nominating Committee will propose a Slate of Officers in February for election at the March meeting of the TRIF UNIT of the year in which elections are scheduled.

Nominations may also be made by Letter of Intent or from the floor at the election meeting.

Any member is good standing is eligible for nomination for office.

Election shall be by secret ballot.

In the event there is no contest for a position of Officer, the Secretary shall be instructed to cast one ballot for each such candidate, in lieu of the above procedure.

Term of office: Duly elected Officers shall serve a three (3) year term commencing April 1st.

 $The Secretary shall \ preserve \ all \ election \ records, including \ ballots, for \ a \ period \ of \ one \ (1) \ year.$

### 2017 Medicare Premiums Announced

The Centers for Medicare and Medicaid Services just announced the 2017 Part B premiums for Medicare, and they are going up. For nearly 70% of Medicare recipients, the premium will increase from the existing \$104.90 to \$109. This increase corresponds to the recently announced cost of living adjustment, which aver ages \$5.

For the remaining 30%, who are not protected by the hold harmless provision in the Social Security law, the basic premium will increase from the current \$121.80 to \$134. Recipients in this category include:

New enrollees in 2017

Recipients not yet receiving Social Security

Those with higher incomes (starting at \$85,000 single/\$170,000 married) subject to the Income Related Monthly Adjustment Amount

Those who are subject to IRMAA pay additional amounts beyond the \$134, depending upon their income.

As noted previously, these higher premiums illustrate the exact situation that RPEA raised when we successfully opposed Governor Cuomo's plan to cap the NYSHIP reimbursement of Medicare premiums at the \$104 level. Retirees are not to be viewed as a revenue stream for the state budget, and we commend the legislature for agreeing with us.

This march is the first step towards unifying our communities, grounded in new relationships, to create change from the grassroots level up. We will not rest until women have parity and equity at all levels of leadership in society. We work peacefully while recognizing there is no true peace without justice and equity for all. **HEAR OUR VOICE**.
